Terms and Conditions

RESERVATIONS: A non-refundable deposit of \$500.00 is due upon registration with a copy of your valid passport or valid ID. Air and hotel accommodations are limited on this trip. Be sure to secure your reservation as soon as possible to guarantee your participation. **Final payment by credit card, money order, direct deposit, wire transfer is due (75 days before departure) no later than August 12, 2012. If payment is not received by August 12, 2012 you will be considered cancelled from the trip.** Please note this trip has limited availability and reservations will be held on a first come basis.

RATES: All rates are based on tariffs and value of foreign currencies in relation to the USD in effect as of January 1, 2012, and are based on a minimum participation of 50 people. If the group does not reach the minimum number and/or the rates fluctuate the rates will be subject to change accordingly. Learning Through Travel, Inc. (LTT hereafter) will do its utmost to keep prices as published. Should increases be forced upon LTT by airlines, exchange rates, etc. it reserves the right to surcharge a fee of up to a maximum of 15% of tour cost.

INCLUDED: Air transportation from your choice of departure city (if you have not chosen the "Land Only" option) hotel accommodations, transportation throughout Peru, English Speaking Guide and Escort throughout Peru, hotel taxes and service charges, meals as per program, workshop fee, grid work.

NOT INCLUDED: Airline taxes, fuel surcharges, airport security charges, meals not listed in program, soft drinks, coffee, tea (except at breakfast), alcoholic beverages, travel insurance, tips to guides, escorts, transfer personnel.

TRAVEL INSURANCE: Learning through Travel strongly recommends the purchase of travel insurance with Travel Guard International (www.TravelGuard.com) as an additional security in the case of cancellation, interruption of travel plans, lost or damaged luggage, travel delays, illness, or accident. Please be sure to read all policy information thoroughly and note that if you have a pre-existing condition you must apply for the insurance within 14 days of the trip deposit date. Travel insurance only applicable to U.S. and Canadian Citizens.

CANCELLATION:

- Deposit of \$500.00 per person is non-refundable
- If cancellation occurs 74 days to 45 days prior to departure, you would lose your non-refundable deposit and an additional \$1,500.00 per person cancellation fee plus any non-refundable pre-paid expenses and administrative fees.
- If cancellation occurs 44 days or less prior to departure, registrant will be considered a "no show" resulting in forfeiture of all monies paid.
- No refunds will be issued for unused portions of the trip.
- All cancellations must be made in writing to LEARNING THROUGH TRAVEL, INC.
- The dated letter of cancellation will calculate cancellation penalties. Refunds due will be processed 6-8 weeks from date of the arrival of cancellation letter,

CHANGE FEES: Once you reserve your tour, changes are possible subject to availability at the time of the request. Any deviations made to the basic itinerary will incur a \$150.00 service charge plus by any change fees imposed by ground operators or airlines. This cost will be invoiced to you. **If you make roommate changes during the trip, you will be liable for payment of your single/doubleroom fee as well as the single/double room fee for your original roommate.** Any changes while in Peru will be charged to your credit card on file with LTT immediately.

RESPONSIBILITY: Reservation of Right to Decline Reservations and Right to terminate: Learning Through Travel and Azurite Press reserve the right to decline to accept reservations for this trip for any reason in their sole discretion. In the event a reservation is accepted, LTT and AP further reserve the right to terminate any participant (or any member of his/her family) from the tour and/or workshop and its attended activities in the event any participant is declared to be disruptive to the group or others in the country in which the trip/workshop is given and or 2) the participant (or any member of his/her family) violates the customs or rules of the country wherein the trip/workshop is being held. In the event that any participant (or any member of his/her family) is terminated for the reasons listed above, it is expressly understood that the participant (or any member of his/her family) will not be refunded any monies that have previously been paid for the remainder of the trip.
