TERMS & CONDITIONS

Please read and sign Terms and Conditions before signing and returning this form. Please complete the Participant Questionnaire and mail with this form and deposit payment. For additional questions, call Learning Through Travel Inc. toll free at 1-866-853-2711.

Payment: Participants will make a deposit to secure their space on the trip. Space is secured on a first come, first served basis. The balance of the tour cost must be made at least 75 days prior to departure by personal check, money order, certified check. If you choose to cancel your reservation, please do so in writing. If the final balance is not received on time, LTT/PCC reserves the right to treat the booking as canceled by you, and levy cancellation charges.

Cancellation by Participant: Should you wish to cancel your trip, you must notify PCC/Learning Through Travel, Inc (LTT) in writing. Please note that deposits are non-refundable. Please state the reason for cancellation, as you may be covered by your insurance policy (if you have purchased). If notification of cancellation is received more than 74 days before departure, you will only lose your deposit. For notification received less than 60 days prior to departure, cancellation charges areas follows:

DAYS BEFORE DEPARTURE TOTAL TOUR COST LOSS

- Before 75 days Deposit Amount
- 74-29 days 100% air ticket cost, 50% land cost
- 28-0 days No refund

If it is possible to give a larger refund, due to liberal policies by the airlines or hotels, PCC/LTT will of course make this possible. We apologize for having to adhere to cancellation charges. The charges are a result of the fact that our rates are based on group travel, and non-refundable payments to the airlines and accommodations must be made to secure travel arrangements.

Cancellations by LEARNING THROUGH TRAVEL (LTT – HEREAFTER)/PCC: All trips are based on group fares and hotel rates, involving a minimum number of passengers. If this minimum is not reached, we reserve the right to cancel the departure and provide full refund, or offer the trip with a supplementary charge. In this case, you would be notified 8 weeks prior to departure and advised of the supplementary fee. If all group members accept the increase cost, the tour will operate as scheduled. However, if the supplement is not accepted refunds will be issued. We may be obliged to cancel the trip due to reasons of force majeure (acts of god such as earthquakes or floods, war, labor strikes, civil disturbances and/or terrorist activities). In such cases, PCC/LTT or the tour operator will inform participants and refund the portion of the trip cost not already sent to travel suppliers, and use best efforts to recover and refund the balance. PCC/LTT is not responsible for additional costs involved in preparing for the trip that has been canceled (i.e. visa fees, shots or air tickets). Alterations Made to the Scheduled Trip Program: We will make every reasonable effort to provide participants with booked trip arrangements, and changes are rare. However, some changes are unavoidable: changes in airline schedules, delays in departure due to technical problems or weather, hotel closures or overbooking, strikes, decisions by State Governments or Tourist Authorities, and force majeure (natural disasters). In such cases, comparable alternative arrangements will be made. If changes are significant, you will be entitled to commensurate compensation in accordance with the gravity of the change.

Airline Surcharge Information- Airlines, in an effort to stem off financial losses caused by

dramatic recent oil price increases, are exercising their right to increase taxes by instituting fuel surcharges of various amounts depending upon the airline and the destination. Some carriers who have already implemented these fees are increasing them again. Some are introducing them for the first time. It is important that all passengers understand that LTT has no influence over airline decisions to impose surcharges, nor does LTT benefit in any way from those additional fees. If you have already paid, the new charges will be added to your invoice and sent to you. If you are registering, now then the surcharges are already reflected in your invoice. Unfortunately, airlines are increasing surcharges as they see fit and LTT exercises the right to charge you the passenger the increase. Taxes and fuel charges are subject to change until all tickets are issued.

Rates: All rates quoted are based on tariffs and value of foreign currencies in relation to the U.S. dollar in effect as of May 2010, and are subject to change. We will do our utmost to keep to the prices as published. Should increases be forced on us by airlines, exchange rates, etc., we reserve the right to surcharge, up to a maximum of 10% of the tour fare.

LTT/PCC requires travel insurance including medical evacuation, care and treatment, vendor bankruptcy, and trip cancellation. **LTT/PCC** reserves the right to deny trip participation. In the event this should happen, your application and deposit would be returned in full, with a rationale and policy statement.

Responsibility: LTT and PCC acts as agents in making and securing all arrangements for transportation, sightseeing, and accommodations for the tour concerned. LTT and PCC do not own, manage, control, or operate any transportation vehicle, cruise ship, hotel, restaurant, or any other suppliers of services. The suppliers subject to the terms and conditions specify all coupons, receipts, and tickets issued. By accepting the tickets and vouchers you agree (and your parents or guardian if you are a minor) that neither LTT or PCC shall be liable for any loss, injury, damage to you or your belongings or in connection with any accommodations, transportation or other services resulting directly or indirectly from any occurrences beyond its control. LTT and PCC will not be held responsible for breakdown of equipment, strikes, theft, delay or cancellation or changes in schedule of services. All accommodations, services, and facilities are subject to the laws and customs of the countries in which these services are rendered. LTT and PCC reserve the right to make necessary changes in the itinerary or services, to substitute airlines or accommodations or cancel any tour at its own discretion in which case it will be the sole responsibility of LTT to refund money paid. No employee of LTT or PCC can change the terms under which you agree to participate in tours. Airlines concerned are not to be held responsible for any act, omission, or event during the time you are on board their aircraft. The passage contract is use by the airlines involved issued constitutes the sole agreement between you and them, and in purchasing a passage contract as part of this tour the participant (and your parents or guardians if you are a minor) acknowledge and accepts the foregoing conditions.
